#### DUTIES AND RESPONSIBILITIES

• Assesses, plans, implements and evaluates nursing care to meet the needs of clients in accordance with competency guidelines within the established standards of practice and current legislative scope of practice.

- Documents information, regarding new admissions and settling of residents, discharges and transfers of residents;
- Shares knowledge, provides direction, assignment and supervision to unregulated care providers as appropriate.
- Provides input regarding clients' needs, performance, and progress. Attends multidisciplinary care meetings.
- Perform nursing care assessments through participation in hygiene care, nutritional care, nursing supportive care, legal care and cleaning activities.
- Performs nursing care and procedures, evaluates outcomes and takes appropriate action where required.
- Encourages and assists clients in activities of daily living as required, such as feeding, lifts and transfers, bathing, skin care, oral hygiene, and toileting;
- Orders, monitors, administers medication to clients and provides medication reminders, in accordance with established policy and procedures;
- Observes clients and their environments and records and takes appropriate action to correct unsafe conditions, behavioral, physical, and/or cognitive changes.
- Provides emotional support and feedback to clients and their families.
- Completes and maintains related records and documentation such as progress notes, observations, and client charting. Reports problems and/or changes to designated staff.
- Answers general inquires by telephone and in person and provides direction and routine information about programs and policies.
- Accompanies clients on outings such as appointments and leisure activities.
- Places purchase orders with external suppliers, receives supplies, checks invoices against orders and goods received, stores and distributes supplies, and contract suppliers to obtain and provide general information. Pharmacy, FutureMed, provides order info to Food Services Manager.
- May serve meals.
- May perform housekeeping duties such as sweeping and mopping floors, vacuuming, dusting, washing dishes, and laundry.
- Performs other related duties as assigned
