PURPOSE

ROLES

Reporting to the Site Manager, provides dietitian services to residents by performing such duties as: assessing; developing and implementing nutritional care plans; develops standards of nutritional care for residents; participates in planning and implementing education programs; and reviews nutritional concerns with residents and/or family..

DUTIES AND RESPONSIBILITIES

- Assessing the dietary needs of each resident upon admission;
- Determining best nutritional needs for each resident;
- Reviewing the dietary needs of each resident on an ongoing basis as per legislative requirements
- Conducting regular review of resident weights for significant health changes;
- Meeting with Resident Council to determine food preferences;
- Meeting with Food Services and Clinical Services as required to discuss menu planning and resident nutritional needs;
- Establishing and monitoring special dietary needs of residents; and,
- Attending care conferences as required.
- Other duties as assigned.

This position requires the ability to communicate clearly, deal tactfully and work effectively with all Optima Living staff and management.

QUALIFICATIONS AND EXPERIENCE

- Graduation from an accredited school of Dietetics and completion of Dietetic Internship.
